HOMEOWNERS AGREEMENT AND RELEASE FROM LIABILITY

1. **Voluntary Participation.** I acknowledge that I have voluntarily applied to the Central Oregon Builders Association Remodelers Council to have a ramp built at my home. I understand a ramp will be built at my home on June 9, 2012. However, the date may be changed, my home deleted from the project, or the project cancelled by the sole discretion of the Central Oregon Builders Association, or the COBA Remodelers Council.

2. **Assumption of Risk.** I am aware that in participating in this project I may be exposed to personal injury or damage to my property as a result of the activities of the project volunteers, or the conditions under which volunteer services are performed. I understand that all of the volunteers may not be skilled or licensed as contractors. I further understand that the work on my home may not be completed by the volunteers. With knowledge of these dangers I agree to accept any and all risks of personal injury, damage to my property, loss or use and economic consequence.

3. **Release.** In consideration of the opportunity afforded me to participate in this project, I hereby agree that I, my assignees, heirs, guardians and legal representatives will not make any claim with respect to any work performed or materials provided against Central Oregon Builders Association, the COBA Remodelers Council, or against any of the affiliated organizations or either of their officers or directors or the supplier of any materials or equipment that is used by the project or volunteers. Without limiting the generality of the foregoing, I hereby waive and release my rights, actions or causes of action resulting from known or unknown property damage, personal injury or death to me, loss or use or economic consequence, sustained in connection with my participation in the project.

4. **Knowing and Voluntary Execution.** I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND CONTRACT BETWEEN MYSELF, THE OWNER OF THE PROPERTY, AND THE CENTRAL OREGON BUILDERS ASSOCIATION AND COBA REMODELERS COUNCIL AND RAMP CAPTAIN, AND HAVE SIGNED BELOW OF MY OWN FREE WILL.

I further consent to the unrestricted use by the Central Oregon Builders Association and COBA Remodelers Council and or any persons authorized by them of any photographs, interviews, videotapes, motion pictures, or similar visual or auditory recordings of me or my home.
